Interest Rates and Interest Changes	
<b>Annual Percentage Rate (APR) for Purchases</b>	<b>0%</b> Introductory APR for twelve (12) months. After that, your APR will be <b>6.75%</b> .
<b>APR for Balance Transfers</b>	<b>0%</b> Balance Transfer APR for six (6) months. After that, your APR will be <b>6.75%</b> .
<b>APR for Cash Advances</b>	<b>6.75%</b>
<b>How to Avoid Paying Interest on Purchases</b>	You have at least 25 days after the close of each statement period to pay your balance in full without being charged interest. There is no grace period for cash advances.
<b>Minimum Interest Charge</b>	<b>None</b>

**How We Will Calculate Your Balance:** We use a method called "average daily balance (including current transactions)." See your account agreement under Finance Charge for more details.

**Loss of Balance Transfer APR:** We may end your Balance Transfer APR if you make a late payment.

**Billing Rights:** Information on your rights to dispute transactions and how to exercise those rights is provided in your account agreement.
